

## **Limited Warranty Certificate**

MCCOWN TECHNOLOGY CORPORATION guarantees that every new Machine and Accessory is free from defects in manufacturing and / or workmanship.

The warranty period is 12 months from the date of delivery / registration as stated in the 'Delivery Report' transmitted MCCOWN TECHNOLOGY CORPORATION.

Any other form of implicit or explicit warranty provided by a third party is excluded from this warranty. Under this warranty it's MCCOWN TECHNOLOGY CORPORATION obligation to restore the efficiency of the unusable or inefficient part for manufacturing defect by replacing it with original parts or free repair. All work during the warranty period must be performed at our main corporate address, at a location within the service network or with the approval of MCCOWN TECHNOLOGY CORPORATION and includes the free repair or replacement of the faulty part.

## Third party warranty:

Some components installed on Machines/Accessories produced by MCCOWN TECHNOLOGY CORPORATION (example but not limited to Engines, Hydraulic components etc), can enjoy the warranty assured directly by the manufacturer

The warranty does not cover defects or malfunctions caused, in whole or in part, by:

- Modification, repair or disassembly of the machine by third parties outside the service network MCCOWN TECHNOLOGY CORPORATION.
- Non-execution of the maintenance prescribed in the operation and maintenance manual of the machine.
- Changes to the machine without the prior permission of the manufacturer.
- Carelessness, accidents, late notification of the defect, improper use of the machine, repair with nonoriginal parts, damage caused by prolonged use of the machine under fault conditions.
- Alteration of the machine.

The warranty does not cover normal wear of the components and the defects caused by it, in particular does not cover components such as tires and blades, the replacement or topping up the oil and other fluids, filters, belts, lamps, etc.

The warranty is voided if the fault was not reported within thirty days of its occurrence. Also not covered are factors beyond the control of the manufacturer, such as:

- a) Improper use of the machine, overload, prohibited actions listed in the use and maintenance manual of the machine.
- b) Incidents such as collision, fire, theft, etc.
- c) Alteration, modification, tampering, failure caused by attempted repairs performed by non MCCOWN TECHNOLOGY CORPORATION Service dealers.
- d) Damage or surface corrosion caused by the environment such as acid rain, exposure to corrosive environment or saline, chemical products, events and natural disasters.
- e) Damage due to lack of proper maintenance, operation with improper fuels and oils.
- f) Normal wear and tear or alteration by discoloration, warping, fading, blur, etc.

## Things charged to the customer:

- a) Services for routine maintenance such as cleaning, polishing, lubrication, topping up and oil change, coolant, filters and seals.
- b) Maintenance services described as "Scheduled Maintenance Services", extra expenses or damage as but not limited to: financial losses, although because of the loss of use of the machine, cost of hiring substitute means, housing costs, expenses travel, loss of profit and any other costs or damage.
